- 3. You will require consent from your Healthcare Professional in order to access this upgrade (which includes determining the glucose target settings) when starting MiniMed 780G with SmartguardTM.Further details will follow including a 780G Order Form for completion.
- 4. Warrantv dates do not reset. The warrantv date of an insulin pump upgraded with the software will remain

the same as the warranty date of the initial pump purchased.
